STUDENT AGREEMENT
POLICIES AND PROCEDURES FOR ENROLLMENT

COMMUNICATION: Please make sure to set your email accounts to allow emails to be accepted from vivaartsseattle@gmail.com. We will NEVER give your personal information to a third party. We will communicate with our students via phone, email and text so please keep your email address and other personal information current.

TUITION: Compete Studio Inc. collects all tuition for the VivaArts Capoeira classes. All tuition payments are non-refundable. In the event of extraneous life circumstances, please contact Contramestra Agua-viva to discuss your needs. A 60 day notice is required for any agreement cancellations.

LONG-TERM AGREEMENT: VivaArts Capoeira offers a six-month agreement for kids and a one-year agreement for adults. Our long-term agreement shall become effective immediately after it is signed. Once effective this agreement shall continue to be effective until the last day stated on the contract. In the event of a military deployment, the 60-day notice will be waived. 90 days notice is required for adult long-term agreement cancellations, and 60 days notice for kids. Exceptions to this policy for medical or family reasons evaluated case-by-case.

HOLD POLICY: If a student wishes to pause their program, meaning to place their student account on hold, the financed tuition payments must continue as scheduled during the hold period. Any financed payments paid during this time will be credited to the student's account and added to the end of their yearly program once it has been completed. The only exception to this policy is for medical reasons. In such cases, the student's account may be placed on hold for the duration of their recovery and will resume when the student is medically clear to return. A medical report may be required to verify the seriousness of the circumstance.

DELINQUENT PAYMENTS: Students are expected to keep all tuition payments and billing information up to date.

BATIZADOS AND SCHEDULED PERFORMANCES: VivaArts performs in a variety of different events throughout the year, including annual Batizado Cord Ceremonies. Events are a fun, challenging part of martial arts, and students are strongly encouraged to participate. No student is required to participate. Students will work with their teacher to determine their readiness for participation in events.

ATTENDANCE: Please be on time for class. Regular attendance is essential for success. The Academy cannot be held responsible for a student's failure to attend classes and there will be no refunds given for missed classes.

UNIFORMS AND ETIQUETTE: Students are required to wear clean uniform pants and a white shirt and their cord to each class. Please remember the importance of good hygiene (deoderant and clipped toe-nails please). We also require all students to act with respect to themselves, their co-students, and their teachers at all time.
